Very few people have had the breadth and depth of experience that Chris Kelly has had and we have been the lucky recipients of his devotion to making people's lives better. Her varied professional endeavors include: teaching Head Start, high school and university students; working as a community arts administrator and a leadership educator; and

serving as a State Representative for 8 years. At our luncheon, she will share her experience as one of the very few female state legislators representing our district.

"WHY BOONE COUNTY CONDUCTS BETTER ELECTIONS"

Boone County Clerk and Recorder Wendy Noren will speak at the LWV November Lunch and Learn program at noon, Wednesday, Nov. 19. The meeting will be held in the upstairs meeting room at the Grindstone HyVee.

Wendy Noren has worked on local election administration since 1978, and remembers the 1980 presidential election. "We got slammed," she recalls. "There were thousands of people waiting in line to register to vote." Wendy taught herself COBOL computer language in order to develop processes to quickly register voters and

allow them to vote. She was elected Boone County Clerk in 1982, and has been in charge of all local elections since.

Wendy has also worked with engineers at the University of Missouri to develop procedures, computer programs and equipment appropriate for Boone County elections. In addition, she has served as an international election supervisor in Kosovo.

NOV. 13 FORUM: EARLY CHILDHOOD EDUCATION -- ONE ANSWER TO THE ACHIEVEMENT GAP?



The Education Committee's annual fall forum will be Nov. 13 at 7:00 p.m. (with refreshments at 6:30) in the Friends Room at the Columbia Public Library. Because early childhood education has been the focus of much media and political attention recently, we decided to focus this year's forum on that topic.

Some of you will remember when public school kindergartens were new; now we take them for granted. Historically, most pre-kindergarten education occurred in the private sector or in home settings. With the War on Poverty and creation of the Head Start program, policy makers argued that government-funded preschool programs could compensate for the effects of poverty on school achievement. Today's preschool advocates pin their hopes on the notion that providing high quality programs for all children will narrow the "achievement gap." However, the barriers to that goal are limited access and high costs.

The League of Women Voters has taken a position in favor of expansion of early childhood education. The forum will consider our progress toward that goal as a nation, state, and community.

Facilitated by LWV member Dr. Vena Long, our panelists will dissect the issues from a variety of perspectives:

- Dr. Kathy Thornburg, MU Professor Emerita of Human Development & Family Studies, will share her observations of the expanding interest in early childhood at the national and federal levels and what other states are doing in this area.
- Dr. Stacey Preis, DESE Assistant Commissioner for the Office of Early and Extended Learning, will discuss Missouri's policies and programs, including recent state legislation and an important grant application under review.
- Belinda Masters, Director of the Parents as Teachers program for Columbia Public Schools, will provide an overview of what the district provides and why public educators have become involved in programs for pre-kindergartners.

Following the panelists' talks, there will be time for audience questions and discussion. In addition, our committee will prepare a handout on the patchwork of preschool options, both public and private, in the Columbia area.

OCT 24 PRESS RELEASE: LEAGUE OPPOSES AMENDMENTS

The League of Women Voters of Missouri announced its opposition to three Missouri constitutional amendments on the November 4th ballot:

- Proposition 3 Missouri Teacher Performance Evaluation
- Proposition 6 “Early Voting”
- Proposition 10 Missouri Gubernatorial Budgetary Recommendations

The Missouri Teacher Performance Evaluation amendment would require local districts to use state-approved student performance measures to evaluate how teachers are evaluated. The League believes that if passed, local control would be lost. Teachers are evaluated by local districts now and can be terminated for poor performance through due process. The amendment would mandate more standardized testing leading to more “teaching to the test” and increased costs for local school districts.

The “Early Voting” amendment would allow limited early voting only if the Missouri legislature chooses to fund it. The proposed system is more restrictive than 29 other states, including Iowa, Kansas, Illinois and Arkansas. It prohibits voting on weekends and voting at locations other than the boards of elections, key feature of early voting; and allows voting for six unspecified days, except for the Wednesday before the election. The League believes that we should increase access to voting through REAL early voting systems. If passed, this constitutional amendment would make it very difficult to put in place an early voting system that will encourage citizens to vote.

The Missouri Gubernatorial Budgetary Amendment limits the governor’s powers to propose a state budget and allocate state funds. The governor is responsible for a balanced budget. Governors in all states except Maryland have this power because it is necessary. The League believes that this gubernatorial power is essential to balance the budget when revenues fall and expenditures need to be cut.

The League of Women Voters believes that democratic government depends upon the informed and active participation of its citizens.

This December, the League of Women Voters of Columbia-Boone County celebrates our 95th Anniversary. Our role has evolved from the women’s suffrage movement to working to ensure that all citizens are well informed when casting their ballots.
